



Hire Agreement Form and Disclaimer for Inflatables

Including Terms and Conditions of Hire

1. To ensure sufficient power supply is available to uphold the Inflatable for the duration of the rental. No generators are provided.
2. To ensure there is a designated spot for the Inflatable, which has met the measurement requirement.
3. To ensure there is a proper entry way to the designated spot for the Inflatables. Lifting of any inflated or non inflated Inflatables is forbidden in any circumstances.
4. To ensure the designated spot for the Inflatable is cleared and prepared for the Inflatable.
5. To ensure proper and detailed address is given in order to receive your Inflatable at the allocated time you have reserved it for. Failure to give an adequate address may lead to late delivers or Inflatable not being delivered.
6. All Inflatable has an age limit (please ask attendant for further details). Please ensure no-one over this age uses the equipment .No adults are to use the Inflatable.
7. No food ,drinks, chewing gum or candy are to be allowed on or near the Inflatable which will avoid choking and mess (Please note if the Inflatable is collected in a dirty condition then the person hiring it will incur a cleaning charge)
8. Do not allow anyone to be on the Inflatable during inflation or deflation as this is dangerous.
9. All Inflatable are provided with a 100 foot extension cord.
10. All Wet Inflatables are not provided with a water hose or water.
11. All Inflatables are not permitted on the beach.
12. All Inflatables are only permitted on a grass area or cement pavement.
13. Cancellations or reschedules of all rental equipment must be made three days prior to the delivery or pick up date; if not there is a cancellation fee of \$50.00. No refund, store credit only.
